### **Meeting Opening**

#### **Director's Report**

**Budget Updates** 

- Director is working with new person at Acadia budget report distributed to board members to review
- Presented a handout with budget adjustment. Projected budget was adjusted for an enrollment of 165 instead of 170. Budget is still at an overage for next year but less than

previously estimated. Motion to approve budget adjustments by Thomas, seconded by Stollenmaier. Unanimous.

- Overall the TRCS budget is in a good position compared to other schools.

### Title 1 Federal Funding

- Director worked on documentation for Title 1 federal funding. Officials toured and shared that "it is good to see a school with a clear mission and happy children."
- Supposed to have a parent on a committee to help decide what title 1 funds are spent on and this is supposed to be updated each year. Parent engagement policy says there is supposed to be a group of parents that can be used as a resource to help decide distribution of title 1 funding.

Campus beautification is ongoing and Rowen Todd came by with his company to pressure wash various places all over campus.

## Lottery

There are more people applying and less people saying they are leaving. Enrollment Numbers could be as high as 180 but there is typically an 8% loss

One class has a lottery and there are 5 spots and 6 applications. Director would like to add 1 more seat to the class to accommodate this one application.
